Mayor Joe Bishop and the Council of the City of Pineville, Louisiana, met in regular session on Tuesday, March 11, 2025, beginning at 5:00 p.m. in the Council Chambers of the City Hall, 910 Main Street, Pineville, Louisiana

- 1. Mayor Bishop called the meeting to order.
- 2. Councilman Martin gave the invocation.

5. A motion was made by Councilman Dorn and seconded by Councilman Bouchie to accept the minutes of the February 11, 2025, regular meeting as published. There were no comments heard. On vote, the motion carried unanimously.

- -- Mayor Bishop took the liberty to recognize Dr Mark Johnson, the newly elected President of Louisiana Christian University, who was in attendance and took to the podium. He also recognized Mr. Randy Wiggins, who was in attendance and is a candidate for the Rapides Parish Policy Jury District B seat. He thanked Pineville Marshal Murphy Rachal for attending as well.
- 6. The financial report was given by Finance Director, Mr. David Humphries. February sales tax was up year-over-year by 2.03% ... over \$26K. Occupational licenses were up over 18%, largely due to March 1st being the delinquent date. There were no further comments heard.

PUBLIC HEARING was held for the adoption of an ordinance to amend and modify the Code of Ordinances, Chapter 40, Article II, Section 40-42, 40-43, 40-44 and 40-45, to allow the Mayor, with written consent of the Council to be ratified at the following Council meeting, to determine the size of the increase or decrease of water rate adjustments, not to exceed the percentage rise or fall of the annual Consumer Price Index (CPI). City Attorney, Mark Vilar, indicated there is an error on the title of this Ordinance and requested the Council adopt the item with the amended title (they have) instead of what is written on the agenda. He assured the Council that the content of the Ordinance remains the same; only the title is incorrect. Mayor Bishop reminded those in attendance this ordinance provides for the authority to increase rates that are lower than the CPI. There were no further comments heard.

Mr. Vilar indicated there have been some changes in the law since this was introduced last month. He requested the Council to hold this over for the next meeting to give him time for further review. There were no further comments heard.

A motion was made by Councilman Martin and seconded by Councilman Dorn to table an ordinance to amend and modify the Code of Ordinances, Chapter 40, Article II, Section 40-52, relative to rate adjustments to water consumption charges for residential and commercial customers. There was no Council discussion. On vote, the motion carried unanimously.

Mayor Bishop informed the audience that seven members of the Pineville Police Department took the test and they all passed. There were no further comments heard. Mayor Bishop explained we are donating the Porta Potty Trailer to the Rapides Parish Sheriff's Department, who will make repairs and we can still utilize it. There were no further comments heard. On vote, the motion carried unanimously.

- 15. A motion was made by Councilman Bouchie and seconded by Councilwoman Frederic to approve a resolution to accept the contract of Diamond B Construction Company, LLC, for the project entitle *RUNWAY REHABILITATION AT PINEVILLE MUNICIPAL AIRPORT* as "Substantially Complete." City Engineer, Tom David, explained this has been a two-year process and the runway is expected to last for 20-years. The project cost about \$2M and all the money came from the State's Department of Aviation. There were no further comments heard. On vote, the motion carried unanimously.
- 16. A motion was made by Councilman Dorn and seconded by Councilwoman Frederic to approve a resolution to accept the contract of Central Electric Co. of Alexandria, Inc., for the project entitled AUXILIARY POWER GENERATORS AND SWITCH GEAR IMPROVEMENTS AT PRIMARY WATER WELLS (CAPPELL STREET, LA HWY 107, JANET DRIVE AND PAPERMILL ROAD) as "Substantially Complete." Mr. David explained the City received a compliance order from the State to have these auxiliary power generators installed and now we are well prepared for outages with generators on 6-7 wells. There were no further comments heard. On vote, the motion carried unanimously.
- 17. A motion was made by Councilwoman Frederic and seconded by Councilman Martin to introduce and accept for publication an ordinance to amend and modify the Code of Ordinances, Chapter 38, Article VI, Section 38-162, relative to vehicle speed limits including all school zones and an exception for Pineville High. Mayor Bishop explained this is to allow the speed limit for the Pineville High School Zone to be increased to 20 miles per hour, due to the hill on Claiborne Street. There were no further comments heard. On vote, the motion carried unanimously.

A motion was made by Councilwoman Frederic and seconded by Councilman 18. Dorn to introduce and accept for publication an ordinance renewing the franchise agreement granting to ATMOS Energy Corporation (a Texas and Virginia corporation with its principal office in the municipality of Dallas, Dallas County, Texas) and its successors and assigns the franchise and rights to conduct in such municipality the business of acquiring, maintaining, constructing, laying, repairing, removing, replacing, installing, operating, and disposing of a gas system for the sale, transportation, and distribution of natural gas within and beyond the municipal boundaries of the municipality and to the residents and businesses located therein for light, heat, power, and any other purposes and the right to use the present and future streets, roads, highways, alleys, bridges, public ways, and immovable property in such municipality and owned or controlled by such municipality for such purposes; prescribing the terms and conditions to which such franchise and rights are subject; and prescribing the term of such franchise and rights. Mayor Bishop explained this is just to renew the Franchise Agreement with ATMOS Energy, which is at 4%. There were no further comments heard. On vote, the motion carried unanimously.

At this time Mayor Bishop opened the floor up for any other business to come before the Council. Councilman Bouchie and Dorn "thanked" all the City employees for their hard work in putting on the Mardi Gras Parade and the Mardi Gras on the Red celebration. On a personal note, Councilman Dorn expressed appreciation to Pineville First Responders. Mayor Bishop also "thanked" City employees for their hard work serving the citizens of Pineville. He let attendees know that we recently placed picnic tables and BBQ pits at the riverfront flag pole for folks to enjoy themselves by the river. There being no further business, a motion to adjourn was made by Councilman Bouchie and seconded by Councilman Martin at 5:29 p.m. Councilman Dorn prayed the benediction.
